ENROLMENT REQUIREMENTS:

Candidates for enrolment in the 1st year of the study programme must have completed study programme in the fields of social sciences, law, education, business or administration:

- a 4-year first-cycle study programme in the scope of at least 240 ECTS (post-reform study programme, approved after 11 June 2004),
- a 4-year undergraduate study programme (pre-reform academic study programme, approved before 11 June 2004),
- a specialisation study programme following professional or. academic higher education (pre-reform study programme, approved before 11 June 2004),
- a 3-year first-cycle study programme in the scope of 180 ECTS (post-reform study programme, approved after 11 June 2004),
- a higher professional study programme (pre-reform study programme, approved before 11 June 2004),

Candidates from the fourth and fifth bullet point of the above paragraph have to complete study requirements in the scope of 120 ECTS by the end of their master studies.

Graduates of other fields who completed their education in one of the above mentioned manners must complete study requirements in the scope of 12 ECTS prior to enrolment in the study programme. This can be done in the frames of first-cycle education, in the frames of a supplementary study programme or in the form of bridging exams of ISSBS first-cycle study programme courses.

Criteria for the selection of candidates in case of the number of applicants exceeding the number of places available:

In this case candidates are selected based on their grade average achieved in their most recently completed studies.
