

**PRICE LIST FOR SERVICES IN THE ACADEMIC YEAR 2022/2023**

The 2022/2023 service price list was adopted at the 111<sup>st</sup> meeting of the Administrative Board on 4 July 2022. The price list enters into force on 1 October 2022, with the exception of segment A) Tuition fees per study year and B1) Registration fees which both enter into force upon adoption by the Board.

Value-Added Tax (VAT) which is not accounted in accordance with the Law on Value Added Tax (Official Gazette of the Republic of Slovenia, No. 13/11 – official consolidated text, 18/11, 78/11, 38/12, 83/12, 86/14, 90/15, 77/18, 59/19, 72/19, 196/21 – ZDOsk, 3/22 and 29/22 – ZUOPDCE), is **not included** in the prices. VAT is charged only for issues of duplicates under point B2.2 and under point III) Other services. Exceptions are points 7.1a, 7.1b, 7.1c and 7.2 under point III) Other services where VAT is not charged. The price list enters into force on the day it is adopted by the Administrative Board.

<sup>1</sup> In accordance with Article 77 of The Higher Education Act (Official Gazette of RS, Nos. 32/12 - official consolidated text, 40/12 - ZUJF, 57/12 - ZPCP-2D, 109/12, 85/14, 75/16, 61/17 - UPS and 65/17; hereinafter HEA), residents of the Republic of Slovenia and residents of the Member States of the European Union may be charged for tuition fee if they already have the level of education that is equal to or higher than the level of education of the programme they are enrolled in, or if they do not yet have the same level of education as acquired with the programme but their student status expired in the previous study programme according to Article 70 of HEA.

In accordance with the Rules on tuition fees and stays in public dormitories for Slovenians without Slovenian citizenship and foreigners in the Republic of Slovenia (Official Gazette of RS, Nos. 77/16 and 25/19), the tuition fee on the full-time study programmes of 1<sup>st</sup> and 2<sup>nd</sup> cycle is also charged to foreigners (residents of states that are not members of the European Union). The tuition fee for foreigners is charged in accordance with Article 3 of the Rules on tuition fees in the same amount as for residents of the Republic of Slovenia per part-time study programme.

<sup>2</sup> Candidates who enrol in the final year of the study program according to the Criteria for transferring pay the obligations for the completion of studies by credit points. If the costs of paying study obligations by credit points exceed the amount of tuition fees for the year of study of the enrolled programme, the student is charged the tuition fee of the year and not the payment of credit points.

<sup>3</sup> A student who does not obtain a higher level of education by enrolling in the programme has a 50% discount on tuition fees and the tuition fee is 1.250€.

<sup>4</sup> A 25% discount on the tuition fee is granted, thus the tuition fee is 1.875€. A student who does not obtain a higher level of education by enrolling in a higher year has a 50% discount on the tuition fee, which is in this case 1.250€. The additional year is accounted according to the missing ECTS points and the "Detailed instructions for determining the additional year of the master's study programme of the 2<sup>nd</sup> cycle Management and Quality in Education (MQE)". For applications for the recognition of knowledge and skills submitted to CSA by the deadline defined in the "detailed instructions for determining the additional year", the value of 1 ECTS is 20€, for applications submitted after the deadline 1 ECTS is 37€. The invoice for the additional year is issued after the end of the 1<sup>st</sup> year and the payment can be made in three installments.

<sup>5</sup> If a student has less than 60 ECTS per year, the price is 67€ per ECTS. If a student has to complete study obligations from the master's programme prior to enrolling in the programme, the price for one ECTS is charged

in proportion to the tuition fee of the 2. cycle (2.500€) and then a 50% discount is granted. The price for one ECTS is 21€.

<sup>6</sup> If someone who already accomplished part of the programme's ECTS prior to enrollment, as a member of Lifelong Learning, chooses to enroll in the programme, the account of the paid credits will be made in the first year of enrollment in the programme. Therefore, the amount of tuition fee for the first year is the difference between the already paid amount and the tuition for the study year.

<sup>7</sup> If extracted from the ISSBS, they are not returned.

<sup>8</sup> Should a student remain without a student status during the studies, he or she pays the administrative costs for contributions for persons without student status. The student is charged with the missing study obligations if he or she does not graduate after the expiration of 12 months from the end of the last year for full-time studies in study programmes of the 1<sup>st</sup> and 2<sup>nd</sup> cycle, or after the expiration of 24 months for part-time studies and for full-time studies for which students were charged tuition in study programmes of the 1<sup>st</sup> and 2<sup>nd</sup> cycle, and after the expiration of 36 months for 2<sup>nd</sup> cycle study programmes at which students have to complete an additional year and for 3<sup>rd</sup> cycle study programmes. If the costs of paying study obligations by credit points exceed the amount of the tuition fee for one year of study of the enrolled programme, the student is charged the tuition fee of the year and not the payment of credit points.

<sup>9</sup> The amount can change during the year in accordance with Decision on determination of contributions for special cases of insurance (Official Gazette of the Republic of Slovenia, no. 14/17, 64/17, 19/18, 17/19, 18/20, 36/21 and 38/22).

<sup>16</sup> Obligations for bridging programmes are charged with a 50% discount and have to be paid before taking the exams.

<sup>21</sup> The faculty has the option of charging. Deciding on the extent and form of cooperation.

The application for a decision on recognition of abroad obtained education for the purpose of continuing education is not charged – it is addressed by the Commission for Student Affairs.

<sup>30</sup> The fee for overdue books counts only on work days of the library and begins on the 4. working day after the expiration date of the borrowing. If a member returns the books before the fourth day, he or she is not charged the fee for overdue books. If a member returns the books after the fourth day, he or she pays the fee from the first day on. VAT is not included.

<sup>31</sup> The price of the replacement copy according to the VAT rate of 9.5% and the processing costs at 22% VAT rate.
